1. Installing the CIS Interview System on iPads

Please make sure that the device has a working internet connection. Open the App Store afterwards.

Enter the name 'mobile CIS' into the search box in the top right-hand corner (Fig. 1).



You will get to a detailed screen where you can tap on 'GET' to install the app (Fig. 3).




3. Interrupt, cancel and resume Interviews

Cancel / Abandon:

When pressing the Cancel button in the questionnaire (if there is one), you will be led back to the start screen. It is not possible to continue the interview.

It is possible to abandon the interview by shaking the iPad. The box 'Abandon Interview 'will appear: By tapping on '*Yes*' you will go back to the project selection screen. When opening this project, the next time you will be asked if the last abandoned interview is to be either continued or deleted. By pressing '*Cancel*' you go back to the project selection screen.

Interrupt:

In order to use the interrupt function, an 'Interrupt-Button ' needs to be activated in the questionnaire. After having clicked on this button a unique identifier is created to which the interviewer may add a text. In order to continue an interrupted interview, please press 'Resume ' on the start screen. You will then be shown the interrupted interviews, including the identifier and the (optional) text. If you wish to delete an interrupted interview from the list, please swipe and a Delete-Button will appear.

4. Data upload

Depending on the questionnaires' default settings you can either upload the data manually at any time or automatically after each interview that has been conducted. This setting is not adjustable via the iPad.

Automatic data upload:

After each interview the app tries to connect to the internet to transfer the data to CISnet. When the iPad was successfully connected to the internet, the completed interview will be uploaded. In case there were even more (not yet transferred) data, these will be uploaded as well. In case of a non-existing internet connection the failed upload will be signalized by the appearance of a yellow warning triangle (Fig. 13). The data can be uploaded manually at a later time (see below) or alternatively with the automatic upload after the next completed interview.

Manual data upload:

In case of a manual data upload, you will be informed by the appearance of a yellow warning triangle that there are interview data available to be uploaded (Fig. 13). To start the transfer please choose '*Upload data*' in the menu (Fig. 11 and 12).

After a successful data upload the warning triangle will no longer be displayed.

After uploading data, these data will be automatically deleted from the iPad.

5. Project administration

When using the menu item 'Update projects'

- 1. Newly allocated projects will be installed on the iPad
- 2. In case of questionnaire updates, the corresponding projects will be updated
- 3. Projects no longer relevant or assigned will be deleted from the iPad

To delete a project manually, choose '*Delete project*' in the project specific menu (Fig. 12).

Please note:

In case there are still interview data from a project on the iPad (signalized by the yellow triangle - Fig. 13) the project cannot be deleted.

6. Additional lcons

There are two additional icons in the upper right corner. The info-icon such as the icon for the data protection.

Clicking on the info-icon opens the window with the information about CIS and the application (Fig. 14).
